I. **Call To Order**

Meeting called to order by Commodore Mike Groves at 6:30 p.m.

II. **Secretary's Report:**

Motion made by David Rossiter to accept the Secretary's Report as Submitted. Seconded by Louise Jensen. Motion carried.

III. **Purser's Report:**

Unavailable at this time and will be submitted to the B.O.D. via e-mail at a later date.

IV. **Cruise Master's Report:**

Chuck Boyette stated he did not get enough feedback from the members to be able to decide on Christmas Party for 2017. He will present it again to the members at the next Membership Meeting. He will then let the members vote on what they want. Majority of votes will rule.

Chuck has also made contact with Ocala Travel. He is looking at Carnival Cruises. Prices are not available at his time. It will also depend on who wants a Christmas Cruise or a Spring Cruise. The club would provide the turkey and ham. Members would bring side dishes as usual. After much discussion it was decided we would have our holiday dinner as usual on the third Monday of November and the projected date of the cruise is November 30<sup>th</sup>, 2017

David Rossiter made the motion to combine the Thanksgiving Holiday with our Christmas Holiday. Seconded by John Beach. Motion carried.

Getting back to the cruise. Don Smith stated he always does seven day cruises and the reason he does that is the first day is always a waste. You arrive at noon, departure is at 4:00 p.m. End result you have wasted a day. If you book a five day cruise it's really a four day cruise. Another reason for booking a seven day cruise is it may cost you more but the end it is actually less. If you book a seven day cruise Port Fees and Taxes are right around \$200.00. Also, different cruise lines leave on different days.

Mike Groves stated that he will bring the proposed date up to the membership. The tentative date will be November 30, 2017. Mike felt he will be able to get the members involved with this project.

**Kitchen:**

Louise Jensen states everything is going okay. However, the kick plates at the bottom of the cabinets need to be repaired.

**Helmsman:**

Louise Jensen asked who the presenter was for Ma Barker's. The answer was Joe Voge.

**Open House:**

Bill Hodge stated he's getting help from the members and thanks them. Tom Ulmer has been looking into getting the entertainment. The Smiths, Don and Nancy are looking into the food. The committee has discussed changing the food. Also they would like to have live music this time. The Smith's made contact with Sonny's Bar-B-Que, the Sozo Kids, and others. Bill stated our target is 100 people. The first year we had 62 attendees, 66 the second year, along with our working crew. The music according to Tom Ulmer and Leonard Barnes will run around \$300.00 to \$350.00 for four hours. If we use the Sozo Kids Pulled Pork, that would be \$700.00. The kids would probably like Hot Dogs, so add in another \$20.00 for that. Bill is also getting prices on soda and ice cream. Bill feels the way to go is with the Sozo Kids. All the advertising is free. Bill needs to have the information ready by February 15, in order to advertise properly. Much discussion followed. Bill asked the B.O.D. to vote on his proposal.

Motion made by John Beach to hire the Sozo Kids and a lot \$350.00 for live music. Total amount requested \$1,500.00. Seconded by David Rossiter. Motion carried.

**MISC:**

Mike Groves asked Bill Hodge if we have ever advertised with a Banner on Silver Springs Blvd. The answer was no. Mike stated he would like to look into this.

Mike thinks we should look into getting help for our rentals and finance. Mike stated he would like two people for each position. A primary and a secondary.

**Audit:**

Motion made by Flo Hoffman to audit the books as soon as possible. Seconded by JoAnn Beach. Motion carried.
